Hassett Drive, City Hall, Medford, Massachusetts** at **7:00 P.M.**, on **TUESDAY, November 13, 2007** on a petition of National Grid of Malden, Massachusetts for permission to construct a line of underground electric conduits, including the necessary sustaining and protecting fixtures, under and across the public way or ways hereinafter named.
